I am not adopting this pet for another person. This pet will not be used for experimental purposes or any purpose other than as a pet.

I understand that if I have given false information, or do not follow the terms of this contract that Bella's Promise will reclaim this pet and may start legal proceedings against me, at my expense. I agree that damages may be assessed against me in an amount not less than \$750. I also agree to immediately surrender the pet to an authorized representative of Bella's Promise and also direct all third parties, who may have temporary custody of the pet (such as shelters, vets, etc.) to turn over the pet to Bella's Promise upon its request. I agree to hold these parties harmless.

I understand that the actions of pets are often unpredictable, that pets should be closely supervised when they are with children, that a pet's behavior may change once it acclimates to a new environment, and that Bella's Promise makes no claims or representations as to the health, temperament or mental disposition of this pet.

_____ I understand that pets can be incubating illness which is not apparent at the time of adoption. If the pet becomes ill within 48 hours of adoption, I will contact Bella's Promise immediately. If it appears to be necessary, we will make arrangements for the pet to be examined by one of our veterinarians. Bella's Promise will not be responsible for costs incurred at any other veterinarian.

_____ That the fees associated with adoption are non-refundable.

_____ If the pet becomes lost, I will notify Bella's Promise immediately.

_____ I will contact Bella's Promise and provide any address or phone changes for the pet's records.

I understand that Bella's Promise has relied on the information given in the placement of the pet and that any misrepresentations will result in my losing the privilege of adopting the pet or the immediate removal of the pet from my possession.
